It was also agreed to contact The NFU to enquire if they held a list of all farmers in the Parish (AF)

Alan will investigate placing an advertisement in the Dunmow Broadcast highlighting the Call for Sites invitation. The agreed size was 3 columns by 12cm. (AF)

It was agreed to post the Call for Sites invitation on both the Parish Council website and the NP Facebook Page. (MS)
